Successful candidates will demonstrate potential for excellence in scholarly research and teaching, and possess an exceptional record of academic achievement. Save in exceptional circumstances, a JD/LLB or equivalent and a doctorate in law or cognate discipline, completed or near completion is required. The successful candidate or candidates will also be expected to make substantive contributions through service to the Faculty, the University, and/or to the broader community.

Responsibilities include teaching at the undergraduate (JD) and graduate levels, conducting and publishing research in top tier journals, supervising graduate students (for senior level appointments), and service to the Faculty's academic activities. Candidates must have the ability to conduct both independent and cooperative research, develop viable and productive research programs, and to teach both undergraduate and graduate courses in a related discipline.

Founded in 1912 the Faculty of Law is the oldest law school in Western Canada. Faculty members are recognized nationally and internationally as leading scholars and teachers, and lead by example in their service to the university, legal and civic communities. Alumni include the former Chief Justice of the Supreme Court of Canada, leading judges, academics and lawyers.
