### **Recruitment needs for the position:**

The call is aimed at recruiting one or more professors who can contribute to the development of research and teaching within several compulsory subjects as well as related electives at five study programmes at the faculty.

Applicants must have a research profile and teaching experience that clearly contributes to one or more of the above-mentioned subjects/programmes.

It is a prerequisite that the applicant can teach the above-mentioned subjects/programmes, and it is also a clear advantage if the applicant, based on his/her teaching experience, can document the ability to teach widely on the faculty's study programmes within his/her subject areas.

Please notice that these subjects are taught in Danish. Applicants are therefore expected to either be able to teach in Danish at the time of the application, or to acquire proficiency in Danish that will make it probable that the applicant will be able to teach in Danish within 3-6 years. The faculty actively supports that those employees who at the time of employment do not have any further experience with Danish (or any other Scandinavian language) in writing or speech are enabled to acquire these abilities.

subject area, both nationally and internationally.

- Fulfilling teaching and administrative obligations, including course management, subject area development at the highest international level and, in this connection, performing research-based teaching and examinations together with administrative obligations within a subject area together with supervision of bachelor, master, and PhD students, etc.
- Knowledge exchange with society and participation with academic knowledge in the public debate.
- Research management, including by attracting external funding of salaries for research projects, by guidance and supervision of assistant professors and other researchers, and by participating in academic assessment work.

The professor is obliged to develop and maintain his/her competencies in research, teaching and pedagogy. In addition, other tasks may be assigned to the faculty, and the weighting between the different tasks may vary over time.

### Qualification requirements

In addition to the recruitment needs highlighted above, recruitment will place decisive emphasis on:

- documented high degree of original scientific production at international level, including that the applicant has further developed the subject area(s). In this connection, emphasis is placed on publication in nationally and internationally leading journals/publishers and experience with research presentations within the field's leading conferences at international level.
- Ability and plan to continue to further develop the subject area, including theory development and publication of research that relates to and develops "state of the art" within the subject area.
- ability to and experience with research management and performance of other management functions, e.g. through documented ability to enter into and build an active and strong collective research environment as well as attracting external funding in the form of salary funds for the same;
- teaching qualifications at a very high level, including for the development of research-based education, teaching aids and significant and broad experience in the implementation and development of research-based teaching in the field.
- good interpersonal skills as well as the ability to build research and teaching environment around one's research and subject area.

Terms of appointment and salary will be in accordance with an agreement between the Ministry of Finance and The Danish Confederation of Professional Associations (AC). 1. **Application / letter of motivation**
2. **Curriculum vitae**
3. **Diplomas.** Documentation of qualifications (degrees/diplomas, PhD diploma etc.)
4. **Publications list.** Complete numbered list of publications included in the application.
5. **Teaching portfolio.** This must include documentation for teaching qualifications, evaluations as well as a brief statement of the applicant's teaching visions within the research area. Documentation of experience with the operation and development of education, pedagogy and didactics at a strategic level should be included in the teaching portfolio as well. For more

6. **Research plan.** An outline of planned research activities, including publications plans and plans for applications for external funding. The plan must be ambitious and structured and also document the applicant's skills to contribute to research in one or more of the Faculty's research centers and environments, including how research can benefit the students in one or more of the Faculty's study programs.
7. **Publications.** A maximum of **seven (7) scientific publications** that the applicant wishes to have included in the assessment, of which no more than **three (3) may be monographs**. Applicants, who have written a **doctoral dissertation, PhD thesis or equivalent, must always submit the complete thesis and the written assessment** of the thesis as a part of submitted publications if the thesis is written in one of the languages mentioned below. A PhD thesis written in another language may be submitted, but the Assessment Committee is not required to assess the thesis. The submitted research publications must be written in Danish, Swedish, Norwegian or English
8. **Co-author declaration.** If citing work where the applicant has been a co-author, a co-author declaration, which addresses the applicant's share of these works, must be submitted. Material that has not yet published can be submitted. However, please indicate if this is the case.

In addition to the material which the applicant has wished to have included in the assessment, the assessment committee may include additional material in its assessment of the person concerned. Where appropriate, the applicant shall forward the dossier to the Committee on request.

### Appointment procedure

The application, appendices and the scientific works are uploaded electronically via the link below. The material must be in Adobe PDF or Word format. ZIP files cannot be uploaded.

We recommend that you have all the required documents ready before you begin your online application and it is important that all required documentation is attached.

Automatic confirmation of receipt of the uploaded application will be sent.  
Applicants will be informed about the process on an ongoing basis via email.

After the application deadline, the appointing manager, with advice from the recruitment committee, selects which applicants proceed to assessment. The applicants are selected on the basis of an overall assessment of which applicants best match the faculty's recruitment needs and the qualification requirements stated in the vacancy notice. This is compared with the applicant's research and teaching profile, which appears in the application's CV, list of publications, teaching portfolio and research plan.
