Research Associate

An appointment as a Research Associate may be offered to an applicant who has an LLM (Hons) degree and a minimum of two years' post-graduation experience.

Research Fellow

An appointment as a Research Fellow may be offered to an applicant who has recently obtained a Ph.D. degree in law.

Senior Research Fellow

An appointment as a Senior Research Fellow may be offered to an applicant who has a PhD degree in law and a minimum 3 years' post-doctoral research experience.
