CML is inviting applications from suitable candidate(s) at the beginning of their professional careers to conduct research and participate in CML's work. Depending on qualifications, background and expertise, the successful applicant(s) may be appointed as a **Research Assistant, Research Associate, Research Fellow**, or **Senior Research Fellow** in CML.

## Duties

The duties associated with the position(s) are as follows:

1. The successful applicant must be **in residence** throughout his or her appointment, subject to the NUS standard annual leave (28 working days per calendar year).
2. Depending on experience, the successful applicant will be expected to develop his or her own research agenda, undertaking research projects on **commercial maritime law**.
3. The research agenda must include publication (or acceptance for publication) in an English-language refereed journal during his or her term of appointment and at least ONE working paper accepted for publication in the *CML Working Paper Series* (<https://law.nus.edu.sg/cml/publications/>).
4. The successful applicant will be required to present his or her research and participate in and contribute to CML's in-house seminars and the weekly Mondays@10.30 meeting.
5. The successful applicant will assist in CML's research projects and initiatives, including but not limited to the CML CMI Database *Judicial Decisions on International Conventions* (<https://www.cmlcmidatabase.org/>).
6. A successful applicant appointed at the level of **Research Assistant** will normally act as a research assistant to the Director of CML or, depending on future career plan, to work on his or her own research.

## Requirements

The selection committee will consider the following criteria in making an appointment for the position of **Research Assistant, Research Associate, Research Fellow, or Senior Research Fellow** in CML:

5. The successful applicant must be of exceptional calibre and able to work largely independently with minimal guidance and within agreed timelines.
6. For appointment as a **Research Assistant**, the successful applicant must have – or expect to complete – an Honours degree (or equivalent) **in law**. For a permanent position, the applicant should have a postgraduate degree in maritime law (or demonstrate an interest in pursuing such a degree) and an interest in **commercial maritime law**.
7. For appointment as a **Research Associate**, the successful applicant must hold a postgraduate (LLM) degree and relevant experience in **commercial maritime law**.
8. For appointment as a **Research Fellow**, a doctoral degree (PhD or equivalent) in **commercial maritime law** is essential.

9. For appointment as a **Senior Research Fellow**, a doctoral degree (PhD or equivalent) and post-doctoral experience in **commercial maritime law** are essential, as is demonstrated capability to achieve research excellence.
10. Applications are invited from those with interests in any branch of commercial maritime law, admiralty law, or marine insurance law, broadly understood, including the international sale of goods carried by sea, maritime conflict of laws, maritime dispute resolution (including maritime arbitration, especially in the Asian context), and offshore oil and gas and energy law.
11. A demonstrated interest in contemporary developments in maritime law is essential, as is a proposal complementary to the interests of CML's existing research staff.
12. Applications are **not** invited from persons whose primary interests fall within the **international law of the sea, ocean law and policy, or international environmental law**. Applicants with interests in these fields should apply for positions, when available, in the **Centre for International Law (CIL)** or the **Asia-Pacific Centre for Environmental Law (APCEL)**.

### Application procedure

Applications must be submitted via the NUS Career Portal. These must comprise:

1. Covering letter

This should explain the reason for your interest in a position in CML, why you believe you meet the requirements for the position for which you are applying, and address your ability to perform the duties listed above.

2. Curriculum Vitae

A detailed curriculum vita should be submitted containing complete and detailed information on academic institutions, honours, awards, all publications to date, and all professional experience (current and previous, including dates of employment and job descriptions).

3. Letters of Recommendation

The application must be supported by two references from **academic referees**. Applicants must arrange for their referees to send references to [lawresearchappt@nus.edu.sg](mailto:lawresearchappt@nus.edu.sg) by the closing date.
