Responsibilities:

The successful candidate will contribute to all three pillars of academic life: teaching, research, and service.

The position is designed to support instructional needs in high-demand core areas of private law including first year private law curriculum (contracts, torts, or property) and upper year curriculum including Commercial Law, Corporations, Taxation Law, and Ethical Practice.
